Greetings:

On January 8, 2015, our office responded to your December 3, 2014 request for the following records:

“We, BradyCops.Org, file this public record request for any list your office has compiled, maintains or referenced in the identification of police officers within your jurisdiction who would be commonly classified as “Brady Cops” or “Giglio Cops.”

Our classification of the term “Brady/Giglio Cops” would include police officers that have known history of misconduct that would call into question their veracity. So much so, that their lack of veracity could be reportable exculpatory evidence to the criminal defendant, in compliance with the mandates of the following U.S. Supreme Court decisions:

Brady v. Maryland 373 U.S. 83 (1963)  
Giglio v. United State, 405 U.S. 150(1972)”

It has been brought to our attention today that there was an error of inclusion in the information we provided, and we wish to immediately correct that error. To that end, as of the date of your request of December 3, 2014, a corrected response to your request is as follows:
